
In re: APPOINTMENT OF THE PUBLIC DEFENDER FOR PURPOSES
OF RESENTENCING DEFENDANTS PURSUANT TO HEGGS v. STATE

In light of the Florida Supreme Court ruling in Heggs v. State, 25 Fla. L. Weekly S137 (Fla. Feb. 17, 2000), which was revised by Heggs v. State, 2000 WL 551037 (Fla. 2000), and in the interest of judicial economy, the Office of the Public Defender is hereby appointed to represent defendants for resentencing in accordance with the holding set forth in Heggs. It is therefore,

ORDERED AND ADJUDGED as follows:

1. The Motions to Appoint Counsel filed by each defendant on the list attached hereto are GRANTED. Each defendant, in each case on the attached list, is hereby declared to be indigent and entitled to the appointment of counsel to assist the defendant in resentencing proceedings at the Circuit Court pursuant to Heggs.
2. The Public Defender for the Twelfth Judicial Circuit is hereby appointed to represent each listed defendant in petitioning the Circuit Court for resentencing pursuant to Heggs.
