The Clerk of Court for Sarasota County is authorized to utilize the following procedure for violations of Section 327.11(5), Fla. Stats. (requirement that vessels display decal). As set forth in Section 327.73(1), such violation is a noncriminal infraction, with violators required to appear in county court.

When any alleged offender of this statutory section presents to the Clerk of Court, Sarasota County, proof that he or she held a valid decal at the time of the alleged violation, the Clerk is hereby authorized to dismiss such charge upon the accused's payment of a \$5.00 fee to the Clerk.

The form of proof which the accused must present to the Clerk of Court, Sarasota County, shall be a vessel registration decal issued prior to and valid at the time of the date of the alleged offense.

BOATING REGISTRATION DECAL

The Clerk of Court is authorized to utilize the following
procedure for violations of Section 327.11(7), Florida Statutes
(Boating Decal Violation):

Upon presentment to the Clerk of the Court by any alleged
offender of this violation that at the time of such alleged
violation the accused held a valid decal, the Clerk is authorized
to dismiss such charge upon the accused's payment of a five dollar
fee to the clerk.

The form of proof which the alleged offender must present to
the clerk shall be a decal issued prior to and valid at the time
of the date of the offense.
